

Janelle K. Sarauw was re-elected to the 33rd Legislature on November 6, 2018. Senator Sarauw, has penned into legislation bills that support youth development, encourage workforce development, and propel the Territory forward. Her signature legislation, the State Apprenticeship bill, became law during the 32nd Legislature. The bill amends the VI Code related to apprenticeship standards, authorizing and mandating the Department of Labor to promulgate regulations pursuant to becoming a recognized State Apprentice Agency. This means more job opportunities for the youth of the Virgin Islands. Senator Sarauw's ultimate outlook however, is the overall opportunities and quality of life afforded to the VI populace. Throughout her term, Senator Sarauw has also proposed and stated her position regarding controversial bills on the environment, economic development, education, probate, expungement, and was the primary sponsor of the Division of Festival, now law.

Born in St. Thomas, USVI, Senator Sarauw attended Florida Atlantic University on a full volleyball scholarship earning a Bachelor of Arts with majors in Political Science with a concentration in Global Governance; Interdisciplinary Studies of Social Science and a minor in History. She holds a Master of Arts in Organizational Leadership with a certificate in Servant Leadership from Gonzaga University and is a U.S. Government Certified Grant Writer. Senator Sarauw was also honored by Under 35 emerging leaders, NBC News Out, keynote speaker at the Victory Fund LGBTQ Conference 2018, inducted as an honorary member of the Golden Key Honour Society and many other civic awards.



OVERVIEW

With the Territory still adjusting to changes from the COVID-19 pandemic, the Division of Festivals launched the first virtual Carnival in April of 2020. The long-awaited construction on the Paul E. Joseph stadium would require additional funds, per the request of the Governor, and budget hearings resumed with new COVID guidelines in place to ensure bills would be later vetted in the Committee on Rules and Judiciary.

APRIL - MAY

Virtual Carnival 2020

When Senator Sarauw and Senator Jackson penned the legislation Bill no. 32-0308, that would create the Division of Festivals, no one had imagined the possibilities of a pending pandemic.

With the Coronavirus impacting the Territory, Carnival was undoubtedly going to be postponed; or was it? However, the Division of Festivals saw this as an opportunity to take Carnival to the next level. The Department implemented the first ever virtual lineup of what would be the St. Thomas Carnival 2020 to include j'ouvert, concerts, past carnival moments, and a village lineup of performances.

Their ability to think outside the box and plan a variety of social media live performances, parade reruns, and Carnival memories, has showcased the creativity and ingenuity that the newly instituted Division's leadership brings to the table.

"Congratulations to the team at the Division of Festivals and kudos to the Virgin Islands Department of Tourism for their support of this new division, its leadership and their ideas. Given the circumstances, especially so close to the execution time, the Division of Festivals exhibited the true perseverance of the Virgin Islands people and their culture. This year, Virgin Islanders and others within the region, got to experience a Virtual Carnival and that is the type of out of the box thinking and creativity I had hoped for from the Division. In a time of uncertainties and hardships, the Division of Festivals provided an outlet for stress relief for many Virgin Islanders." stated Senator Sarauw.

MAY 6TH

Extension of State of Emergency

On May 6th Legislators met in a Committee of the Whole to hear from members of the Executive Branch to consider the Governor's request for an extension for the State of Emergency Declaration to address Covid-19 matters in the Territory.


Senators heard from the Commissioners and Directors of Department of Health, VITEMA, Department of Human Services and the Election System as they shared concerns and procedures that were being implemented by each agency to reduce exposure and the spread of the virus.

As the Virgin Islands was now dealing with the spread of Covid-19, it was vital to address the Governor's request to extend the State of Emergency. Bill No. 33-0294 would grant the Governor his extension from May 12, 2020 to July 11, 2020. Senators would approve the Bill in Legislative Session held the day after on May 7th.

Also motioned to the floor by Senator Sarauw during Legislative Session was BR 20-1149, which would become Bill No. 33-0298, a bill to reduce the number of signatures needed on nomination papers from 100 to 25 signatures. The number of signatures shall only be reduced to 25 due to the risk of exposure to the coronavirus and resume to the 100 signatures for future Elections.

With Covid-19 as the main focus, it would be conflicting for a candidate to seek signatures when the main goal was social distancing to limit the spread of Covid-19. However, the bill would not move forward to the Governor as it was rejected by majority of the Senator's Democratic colleagues. An outcome that seemed questionable given the circumstances, and rationale just given for the extension of the State of Emergency.







MAY 13TH

Committee of the Whole

With the Territory's main source of revenue taking a direct hit from Covid-19, tourism had reached a new low with no cruise ships and minimal travel into the Territory.

During the Committee of the Whole on May 13th, Senators received an update from the Governor's financial team, the Office of Disaster Recovery, V.I. Housing Finance Authority, USVI Public Finance Authority, VI Government and the Territory in regard to projects, monies, and covid-19. The Director of the Office of Management and Budget (OMB), Jenifer O'Neal, highlighted the issue of the estimated \$150 million revenue deficit for Fiscal year 2020 and the necessary budget cuts to sustain the government.

During the meeting, Senator Sarauw questioned the team on the status of stimulus checks and their method of using 2018 taxes as a means to distribute checks. The Senator shared her concerns about putting Virgin Islands residents at a disadvantage for those who were unemployed in 2019 and for families who had children that year.





On May 17th we honored and recognized the Virgin Islands flag as it was created as a symbol for this Territory.

Bill No. 33-0117 amends title 1, chapter 11 of the Virgin Islands Code by adding a new section 200k designating May 17th of each year as "Virgin Islands Flag Day" in recognition of the day that the Virgin Islands flag was adopted.

FACEBOOK REFLECTIONS

Slavery was officially abolished in America in 1865, a full two years after Lincoln signed the Emancipation Procla mation. It was not until 1866, when slave codes were nullified, that blacks were considered U.S. citizens. Then, in 1866, the Fourteenth Amendment was signed, granting blacks equal rights and equal citizenship. Black men got the right to vote in 1870, when, under the Fifteenth Amendment, suffrage was granted to all male citizens. In 1875, Congress passed the Civil Rights Act, which granted equal treatment for blacks in public, but overturned it in 1883. It was not until 1957 that a new Civil Rights Act was passed, and six years after that, in 1963, Dr. Martin Luther King Jr. declared, "One hundred years later [after a great American signed the Emancipation Proclamation1 the Negro still is not free." African Americans (blacks)have had a tremendous journey from slavery to the present; but true freedom is not just physical, it is emotional and spiritual as well. It's obvious that the tremendous task of ending slavery in this country was only the beginning of freedom for blacks in general. This requires that we become free of the negative impact that slavery has on all Americans, black and white. It requires that we look closely at how we perceive ourselves and how others perceive us, and demands that we have a better understanding of our past history and that of our ancestors, both black and white. #RaceRelations



MAY 21ST

Committee on Health

During a meeting for the Committee on Health, Hospitals and Human Services, Senator Sarauw exposed an underlying issue that continues to plague the Virgin Islands community. Although we are now in the age of modern technology and are in the process of implementing telehealth, the issue of limited care for our homeless and mentally ill population. With COVID-19 being a factor in services, the question was raised on how are services being provided to the mentally ill that do not have access to a phone or computer?

Senator Sarauw highlighted that in the 32nd Legislature money was appropriated for mobile units to help assist in the area of homelessness and the mentally ill. Based on the update from the Department of Health, the vehicles would be on their way to the Territory shortly. However, the department would still express the challenges they are faced with meeting the needs of the population. Each island had assigned outreach workers but with COVID-19 being a factor services would be limited.

Senator Sarauw expressed her concerns for the lack of attention to this matter. "This body has continued to appropriate. Every time there's a mental health issue we give and give but it would be helpful to see some tangible progress," stated Senator Sarauw.

COVID-19 continues to expose the vulnerable areas that needs to be addressed in the Territory.



MAY 29TH

Committee of the Whole

On the agenda for the Committee of the Whole were various zonings for consideration to include yet another gas station on an already over saturated St.Thomas and an up and coming water park.

The water park would get the green light and the Senators' blessings as many were impressed by the business venture that is also owned by young local entrepreneurs.

Senator Sarauw agreed that the business is a much-needed attraction to not only help drive tourism to the Territory, but also to provide locals an alternate recreational opportunity right here at home. "It is in alignment to what the tourism industry has been asking for" stated Senator Sarauw. One concern the Senator expressed was the integrity of the beach and the manmade hole that needs to be addressed from a previous dig years ago. The Senator asked DPNR to address filling the hole to prevent further erosion of the beach so future generations may have it to enjoy.





JUNE 5TH

Paul E. Joseph Stadium

The Committee on Finance met to discuss Bill no. 33-0275 an act appropriating \$8,200,000 from the internal revenue matching fund for the construction of the Paul E. Joseph Stadium Project. The bill was presented by the Senate President, Senator Novelle E. Francis, on behalf of the Governor.

Given the circumstances surrounding the project, which was funded over 20 million and was started and held by previous administrations, Senators found it difficult to justify passing the bill. Especially with the lack of progress with the monies that was allocated for the initial project. Anyone can pass by the project site and see the lack of construction and development. So how was this justifiable?

Senator Sarauw questioned the numerous change orders presented to the committee by the Department of Public Works. Pointing out key people that were there throughout the project throughout the administration changes. "The Paul E. Joseph should be further along in construction." stated Senator Sarauw.

"What has prevented us from laying the first brick" asked Senator Sarauw. "The problem in the Virgin Islands is we don't meet benchmarks. This project started at one price and we had ten change orders after the fact. There's no accountability."

The bill would pass with attached amendments that split the requested amount into two sums to the Committee on Rules and Judiciary for further consideration. Senator Sarauw's vote on the bill as presented was "No."



JUNE 11TH

Committee on Rules and Judiciary

WAPA Oversight Bill To Be Heard

Bill No. 33-0346, penned to establish an oversight management committee for the Water and Power Authority (WAPA), will be heard in the Committee on Rules and the Judiciary on Tuesday September 15, 2020. This legislation is the brainchild of Senators Sarauw, Frett-Gregory and Vialet who have been working on this legislation since September of 2019. Staggering utility rates in the Territory, coupled with poor service and increasing debt pushed the senators to craft this significant piece of legislation as the growing challenges with WAPA continue to plague the community.

The Water and Power Authority, a semi-autonomous agency and the sole power utility in the US Virgin Islands, has been plagued with various, long-standing issues, ranging from outdated infrastructure and equipment, to gross mismanagement. Over the years, this has caused an increasing number of outages throughout the Territory, wreaking havoc on WAPA customers not only in exorbitant utility bills, but also by causing household and commercial equipment failures.

In order to address the severe deficiency of WAPA's ability to provide reliable service at reasonable costs to residents, the trio of senators have been working for several months to research various options for the Authority. Having found that WAPA is unable to adequately serve its customers and manage power utility needs, Bill No. 33-0346 gives the Governor the authority to temporarily appoint an independent management entity with fiduciary oversight to bring the company up to appropriate regulatory and operational standards. The bill specifically outlines the qualifications for each oversight member.

The overarching goal of this legislation is to improve the services offered by WAPA, to address the high cost of use, and to loosen the ball-and-chain effect of resulting debts through effective oversight, coordination, and planning. "As we make strides in our recovery with aims to bolster economic development, we must provide the basic necessities and infrastructure for economic stability to occur. Stabilizing WAPA should be at the top of the agenda," states Senator Frett-Gregory. Senator Sarauw adds to this sentiment, stating, "It is time that we treat WAPA with the urgency of the emergency that it is, our residents deserve the reliability of their utilities in the 21st century."

This legislation presents a vital solution and is very specific to addressing the pressing utility crisis we are currently facing daily. According to Senator Vialet, "It is an attempt to analyze the present administrative structure and to make the necessary changes it requires. The utility will be analyzed by subject area experts."

All three Senators pledged to partner with their colleagues in the 33rd Legislature to gain the necessary support to move the legislation forward. Together, they believe it's time to hold the authority accountable and provide relief to rate payers. Our people cannot wait any longer for decisive leadership.
